# Social capital

• 'Because what happens in the neighbourhood influences our public and social disposition... Social capital refers to features of social organisation such as networks, norms and trust that facilitate co-ordination and co-operation for mutual benefit.'

(Forrest and Kearns 2001: 2137).

#### Tolerance

 'Tolerance is respect, acceptance and appreciation of the rich diversity of the world's cultures, our forms of expression and ways of being human. It is fostered by knowledge, openness, communication and freedom of thought, conscience and belief. Tolerance is harmony of difference. It is not only a moral duty, it is also a political and legal requirement'

(Article 1.1).

#### Tolerance

• Tolerance is not concession, condescension or indulgence.


(Article 1.2)

## Toleration

• The study of toleration also requires qualification but should be reserved for 'the study of the ideas and movements which have emerged historically not merely with a view to justifying or promoting certain types of tolerance, *but with a view* – more accurately- - *to demonstrate certain types of intolerance*'

(King, 2012: 68).
